- 4. Sections 1 & 2 of Part IV are to be completed **on the sheet** labeled Part IV with **NO** additional sheets attached and **signed** by the School Counselor and the Youth Minister / Parish Priest. Please **submit <u>three copies</u>** of this page
- 5. <u>Applicant must not mention his/her name</u> or make any other identifying reference within the essay, on the essay, or Sections I and 2 of Part IV. <u>Failure to comply will result</u> in disqualification.
- 6. Recipient of scholarships will be notified by the local court regent, who will also have additional forms for the recipient to be completed.
- 7. Emailed applications will <u>NOT</u> be accepted.
- 8. Sponsoring court must have enrollments totaling at least \$50.00 before January 31, 2023.
- 9. ALL APPLICATIONS AND ESSAYS MUST BE **POSTMARKED** BY JANUARY 31, 2023.
